# TOWN OF CASTLETON PLANNING COMMISSION MEETING MINUTES OF OCTOBER 22, 2013 TOWN OFFICES

The meeting was called to order at 7:10 P.M by Chairman J. Bruno.

## Set Date for Public Hearing

Chairman J. Bruno stated that J. Potter suggested December 10<sup>th</sup>, 2013. J. Pintello asked if the issue could be voted on again. Chairman J. Bruno stated that the issue is different because of the addition of the third property. He stated that it still has to be approved by the Select Board, and that he asked J. ## Zoning Applicant Interview

J. Biasuzzi stated that he has lived in Vermont for 30 years and has a forestry and real estate background with an expertise in rural property. He stated he has been the zoning administrator for Wallingford since February. He asked how the previous Zoning Administrator's hours worked. Chairman J. Bruno stated that he worked Tuesdays, Thursdays and meetings. J. Biasuzzi stated that he would like to do some work from his home office if that was agreeable to the board. He stated that he feels communication is important, and that he tries to process requests quickly.

Chairman J. Bruno asked if he would have a problem enforcing zoning. J. Biasuzzi stated that he would not. He stated that he will not go looking for violations, but will address them if they arise. He stated that could come in the form of a formal complaint or if he sees a clear cut violation.

J. Pintello asked what office hours he would hold. J. Biasuzzi stated that he would likely have office hours Thursday and one other day, then do meetings and site visits.

J. Biasuzzi asked what the position paid. Chairman J. Bruno stated that it is between \$15 and \$18 plus mileage.
