# FINANCIAL AUDIT REPORT YEAR ENDING JUNE 30, 2016- NATHAN HAWLEY, PACE & HAWLEY, LLC.

M. Shea stated he would look into this.

**Update on Accounts Receivable (School):** As indicated, I was present at the 12/7/16 School Board meeting and expressed that the Town has a long outstanding AR on its' books and wish to resolved it. A historical conversation took place and the Board voted to pay what was due, which is \$7,753.00. I am happy that this is resolved.

M. Combs stated that the actually amount is \$6,253.00

**Fire District #3:** As an effort to keep you in the loop, I have enclosed the latest correspondence from FD #3 as to a bill for \$4,842.58. Belden has received a copy of this and we hope to meet with all in the near future.

**Fund Balance Policy:** At your last meeting, and in your packets you received the draft fund balance policy. This policy is recommended by our independent auditor and categorizes and illustrates fund balances consistent to GASB statement #54. At this time I am asking for consideration on this item

**MOTION:** R. Combs made a motion to adopt the GASB Statement #54 A/K/A as the Fund Balance policy. Seconded by J. Leamy. All in favor. Motion Carried.

<u>Vermont State Police Lease Agreement</u>: The enclosed is the latest draft from town Council. You will notice, not surprisingly, that her recommendation align with our insurance company. At the time, VSP has forward this to their Council.
