J. Bruno asked to have a request for an outside only liquor license for Castleton Pizza & Deli added to the agenda.

**MOTION:** R. Combs made a motion to approve the agenda as amended. Seconded by Z. Holzworth. All in favor. Motion Carried.

# MINUTES FOR APPROVAL: April 9, 2018

**MOTION:** Z. Holzworth made a motion to approve the minutes of April 9, 2018. Seconded by J. Leamy. All in favor. Motion Carried.

## POLICE DEPARTMENT UPDATE- CHIEF MANTELLO

Chief Mantello handed the members a roster for the Police Dept. which was requested at the last Board meeting.

J. Bruno asked what property watch was.

Chief replied that it is when citizens call the Dept. and complete forms and want their properties periodically checked by the Dept.

The Scopion Bowl was this past weekend and it was not as big as last year, and the off campus party was shut down at 7:30pm.

**MOTION:** R. Combs made a motion to approve the First class liquor license with outside consumption for Breting, LLC, DBA Third Place Pizzeria. Seconded by J. Leamy All in favor. Motion Carried.

## REQUEST FOR OUTSIDE CONSUMPTION ONLY- IRON LANTERN

**MOTION:** Z. Holzworth made a motion to approve the outside consumption only Liquor license for Iron Lantern, LLC. Seconded by J. Leamy. All in favor. Motion Carried.

# REQUEST FOR LIQUOR LICENSE APPROVAL FOR OUTSIDE CONSUMPTION CASTLETON PIZZA &DELI, INC (w/BLUE CAT)

J. Bruno noted that this needs to be put on hold until their permit is complete, this should be put on the record.

**MOTION:** J. Learny made a motion to hold the liquor license with outside consumption until there is clarification on the permit. Seconded by Z. Holzworth. All in favor. Motion Carried.

#### **BID AWARD- SEASONAL MOWING & TRIMMING**

J. Bruno asked for clarification on the BID information.

M. Jones noted that the BID sheet show BID #1 & BID #2. There are BIDS for 23 weeks and 26 weeks. BID #1 includes mowing that is paid for by other Depts. And BID #2 is mowing that is paid for out of the Town's budget.

M. Jones had a concern regarding the special care needed around the stones at the historic cemeteries.

R. Combs clarified that BID #1 includes the historic cemetery at Federated Church, Town Green, Castleton Town Library, Dewey Field and Hydeville School and ball field. BID #2 includes the Park & Ride, South Street/Staso Rd. Triangle, Public Service Bldgs. (Police, Fire), Town Office, Hydeville Green, Crystal Haven Common Area & Pencil Mill/North Rd. triangle.

**MOTION:** J. Leamy made a motion to approve BID # 2 to Vermont Dept. of Corrections and BID #1 to Hillside Lawn Care for 26 weeks. Seconded by Z. Holzworth. All in favor. Motion Carried.

# COIN DROP REQUESTS- CASTLETON FIRE ASSOC., EQUESTRIAN TEAM, FHUHS SPANISH CLUB, CASTLETON SENIORS

M. Jones noted that two of the clubs had requested the same date of May 12, which is CU graduation weekend, so he recommended that neither group utilize that date. Each group did request different dates for coin drops, if you disregard the May 12 date.

R. Combs noted that requests have to be made by April 30<sup>th</sup> and there are only 4 coin drops allowed in a year.

#### **MANAGER'S UPDATE**

M. Jones noted that he had no formal update for the Board.

M. Jones informed the Board that the driveway work at the Town Office had begun, it will still be gravel for the open house. It will be ADA compliant with handicapped parking. The grading of roads will start on April 24. C. Bendig will begin street sweeping tomorrow, weather permitting and cross walk painting will be complete for graduation. The roof at the Sewer plant is 70% complete.

M. Jones has been approached by a local church group to begin a Community garden. The fence at the equestrian park at Dewey Field is falling apart and needs to be taken down.

- J. Bruno suggested that M. Jones get in touch with the local 4H group.
- J. Bruno also noted that he thought the land behind the Town Office would be an ideal location for a community garden. If it comes to fruition, the group would have to come to the Board each year for approval.

M. Jones informed the Board that at the May 14 meeting there will be a briefing by Susan Schreibman on the Highway Dept. Capital Improvement plan. The town did pay \$8,000.00 for this plan.

J. Bruno noted that the board authorized the Town Manager to purchase a shed for the Tree warden and trash bins.
