### AGENDA FOR APPROVAL

**MOTION:** Z. Holzworth made a motion to approve the agenda with the addition on review bid analysis for sewer project. Seconded by J. Leamy. All in favor. Motion Carried.

#### PURCHASE ORDER FOR APPROVAL-GENERATOR MAINTENANCE

- R. Spaulding asked which generators was the maintenance for.
- J. Jordan replied that it was for the 5 town generators.
- J. Leamy asked why the breakdown pricing was for each generator.
- J. Jordan replied it was just one total cost for maintenance. It included fluid changes, filter changes and load testing once a year.
- J. Bruno asked if J. Jordan did any testing himself.
- J. Jordan replied that he did start them once a week and more if a storm was projected.

**MOTION**: R. Combs made a motion to approve P.O. 040803 for \$2,877.00 to Brookfield Services for generator maintenance for the WWTF. Seconded by R. Spaulding. All in favor. Motion Carried.

## **REVIEW VEHICLE PROPOSALS**

- P. Eagan noted that R. Ward had made many calls and had all the information inquires.

- R. Spaulding suggested that the Board wait on a decision until they have quotes on 2017 models from Auto Saver group and Springfield Ford.

#### **REVIEW BID ANALYSIS FOR SEWER PROJECT**

Leamy stated that they will possibly have a meeting with DOT and discuss the closing of the intersection for 5 days which would be a savings of about \$50,000.00; also not replacing the sidewalk in front of Coon's store would also save about \$11,000.00. They will ask J. Krupa to come down for a meeting.
