CALL TO ORDER: B. Longtin called the meeting to order at 7:00pm.

TOWN PLAN-VILLAGE DESIGNATION AREAS DISCUSSION -ED BOVE, RRPC

- B. Longtin stated that the village designation areas needed to be completed for the town plan.
- E. Bove stated that they need to work on the Hydeville area. He explained that the maximum amount of acres for each separate area is 125 acres. He told the members they should include as much acreage as possible, as the State has the final say on the village designation boundaries, and could possible decrease the size of the area.
- J. Bruno stated that he has a map from the 1800's that has all the villages marked. He will get a copy of it to E. Bove.
- B. Longtin if E. Bove could help with the maps.
- E. Bove stated to have the map marked out with the village areas and he would have them made up with in the next two weeks.
- E. Bove explained that you can include a preliminary map in the town plan for the public hearings. He will create a "future land use" map and village designation map for the town plan.

REVIEW OF GREEN LANTERN PROPOSAL

- B. Longtin stated that the Planning Commission and Select Board agreed to make the solar array project by Green Lantern a preferred site. The Assessor will need to update the parcel number and address so the paperwork can be signed.
- J. Bruno stated that the net metering agreement will need to be reviewed by Town Counsel.
- B. Longtin asked who should do it.

- B. Longtin stated that he requested the ordinance he based his decision on. J. Biasuzzi referred him to Section 1102.
- B. Longtin stated he read the section and saw no where at demolition was mentioned.
- B. Longtin did recall a past conversation with J. Biasuzzi where J. Biasuzzi had said there was no zoning for demolition, but he would like to see one.
- J. Bruno stated this issue needs to be discussed further and brought to the Select Board for consideration of a refund to the applicant.
