DISCUSSION: COMMENCE REVIEW OF ZONING SECTIONS

J. Currie noted that J. Rosenthal and herself are researching the zoning regulations in Brandon and Wallingford.

J. Rosenthal stated he has been reviewing the Table of Uses. There was a joint meeting with the DRB an Planning Commission and the RRPC. One issue that was brought up was what if a use comes up that does not fit into the Table of Uses. E. Bove cited 2 towns that have simplified their Table of Uses are Brandon and Wallingford.

J. Rosenthal made copies of their zoning and Table of Uses for the members to use a guide. He explained that have districts broken down and within the districts are the conditional uses, prohibited uses etc. Then the there are descriptions of the uses. They have come up with general descriptions, so if something comes up that does not "fit" into the Table of Uses, they look to the descriptions to see if it fits that way.

J.Currie noted that the Table of Uses looks very exposed.

J. Currie used the CBD example (Central Business District), stating that that would correspond possible to our Village Designations.

J. Rosenthal stated he felt a "lake shore" district should be considered in our zoning ordinances.

B. Franzoni stated that it looks a lot easier for someone who is looking to open business in town.

B. Franzoni suggested a workshop with the DRB to work on a new Table of Uses and descriptions.
