<sup>i</sup> As of January 1, 2021, vehicles of model year 2011 and newer are subject to odometer disclosure for 20 years. Under the old rule, a 2011 vehicle would have become exempt from disclosure in 2021. Under the new rule, the odometer reading must be disclosed at the sale of a 2011 vehicle until 2031, 2012 vehicles will become exempt in 2032 and so on.
