RESPONSE TO BIDDER QUESTIONS

Q4.1 A4.1.	What is the expected project duration? 120 Days in the 2021 construction season – notice to proceed in June.
Q4.2 A4.2	What is the general attitude of residents and project abutters? No known concerns - Town and MPM have been working to establish public awareness. A recent similar project had been delayed and there were residents concerned about curb cuts being removed without their knowledge. These issues are not expected with this new project.
Q4.3 A4.3	Is there land available for laydown areas or stockpile yards? There is a small area behind the Town offices. No other Town owned land. Possible areas on private land. Permissions to be obtained by contractor (Grange Hall) but areas must also be approved by MPM, Town and VTrans Environmental Div. All areas must be restored at completion of project.
Q4.4	Is the Castleton Corner Store onboard with the project?
A4.4	We have notified the owner and staff. No known concerns.
Q4.5	I was curious if there was already appox. 2800' of curb and sidewalk and it is just all being replaced? Or if there was going to be new construction of sidewalk in areas where you didn't have sidewalk before?
A4.5	Project consists of installation of new sidewalk within work areas shown. There may be small sections of existing sidewalk that are to be removed and replaced. Project is roughly 2,500 feet in length. See bid tab for material quantities. Alignment stations go to approx 2750 feet including road and driveway crossings.
Q4.6	Is there a bid bond form you need us to use, or is a standard AIA form acceptable?
A4.6	We will accept whatever stand form your surety company typically provides.
Q4.7	Would the owner be open to granite curb alternate?
A4.7	Town preferred concrete curb according to Design Engineer and used concrete curb on the first sidewalk project.
