Meeting was called to order by P. Keller at 7:00 pm.

Approve Agenda

Approval of Minutes of May 23, 2023

L. Sargent made a motion to approve the minutes of May 23, 2023 as presented. Y. DeLance seconded. D. Wood abstained. All others voted in favor. So voted.

Hearing for Application #8269 – Johnson/Anderson, Johnson Spooner Road, Setback Variance P. Keller swore in anyone who may be giving testimony on this application at this time.

J. Thomas explained the application, stating that in May they got a permit approval for a garage that is 50' from the road. The property owner came back in to say that he couldn't put it in as proposed and they decided they needed to be closer to the road, meaning a variance is needed. It would now be a 20 foot setback instead of 50 feet. The accessory building being proposed is 40 feet from the road, from the sides are 10 feet which is within the regulations, it is the road side that is the issue. Discussion on the setbacks and what degree of impact the project has on the landscape of the property and the neighborhood. After brief discussion it was decided that a site visit was needed.

L. Sargent made a motion to recess Permit #8269 until July 3, at which time the applicant will provide a deed and where the roadside pins are located. Y. DeLance seconded. All voted in favor. So voted.
