# Permit Application #8239 – Kin of Mills, Inc. Donald Wong Applicant, 62 Lakeview Lane, Expansion of Non Conforming Use

J. Rosenthal stated the proposal is to tear down the existing seasonal camp and replace it with a year-round dwelling with an additional 459 square feet of space. The existing building lot coverage is 8.2%, new proposal is 11.7%, which is a 3.6% increase in lot coverage. Discussion on the setbacks. Roadside (East) current is 37'6" proposed is 34'6", South current is 56'2", proposed is 52'11", West (lake side) current is 37'5", proposed is 35'5", North current is 17'6", proposed is 15'0". Review and discussion on the detail and layout of the new proposal. Applicant stated he is in the process of application with the State for the shoreline setback change. Current height is 29', proposed is 38'. Landscaping, decking, water supply and septic were also discussed. Discussion on whether the existing larger trees should be taken down

during the construction process and whether the State shoreline erosion regulations apply to the vegetation in question.
