Meeting called to order at 7:04 by Chairman J. Bruno with the Pledge of Allegiance.

#### APPROVAL OF AGENDA

**MOTION:** R. Combs made a motion to approve the agenda as presented. Seconded by R. Spaulding. All in favor. Motion Carried.

## **MINUTES FOR APPROVAL: DECEMBER 28, 2015**

**MOTION:** R. Combs made a motion to approve the minutes of December 28, 2015. Seconded by R. Spaulding. All in favor. Motion Carried

## **APPOINTMENT-PLANNING COMMISSIONER ( 3 YEARS)**

J. Bruno introduced B. Longtin. B. Longtin is a Probation Officer in Rutland. He has lived in Castleton since 2003.

**MOTION:** J. Leamy made a motion to appoint B. Longtin to the Planning Commission for a 3 year term. Seconded by R. Combs. All in favor. Motion Carried.

## APPROVAL OF LOAN APPLICATION & AGREEMENT - CLEAN WATER STATE REVOLVING LOAN

M. Shea stated that this is a 0% loan. The Board agreed that they needed some clarification on the terms. This will be postponed until the next meeting.

# **CONTINUED REVIEW OF 2016-2017 BUDGET**

M. Shea presented the Board with the budget plan. The plan presented had a total increase of 7.5%. The biggest reason for the increase is the cost of insurance.

M. Shea asked the Board for direction in presenting the "Capital Improvement Plan." There are two ways to address it, include the capital items into the 2016-2017 budget or add a line item for each separate "capital improvement".

The Board seemed to agree that having a separate line item would be the way to present this to voters at Town Meeting.

P. Graziano also questioned the justification of a 26% increase in the Constable budget, when the town has a full time Police Dept.

#### MANAGER'S UPDATE

<u>Elm Street Property:</u> At the time of this meeting, this building would have been cleaned out and the for Sale process in on going. Appraisal came in at \$175,000.00. M. Shea will be building a presentation to put on line.

<u>Sidewalk Project Bids:</u> The Second phase of this project is being solicited via the RFQ process for design engineering were due on January 6, 2016 at 1:00pm. Two bids have been received. Moving forward the Selection Committee will be meeting to evaluate the bids and bring this information to the Board for consideration soon.

4<sup>th</sup> of July Discussions: For some time there has been a group of individuals interested in filling a void the town has. This is on a 4<sup>th</sup> of July Celebration. I have included in your packet an email that mentions a few eager individuals that are interested in this becoming a town asset for the community.

<u>Town Meeting Warning</u>: In your packets you will see a basic draft document with thoughts on what we may see in your upcoming meeting. Let's Talk.

<u>Vermont Rural Fire Protection Task Force</u>: Enclosed is a request from Vt. Rural Fire Protection requesting a donation.

**MOTION:** J. Leamy made a motion to donate \$100.00 to the Vermont Rural Fire Protection Task Force. Seconded by R. Spaulding. All in favor. Motion Carried.

M. Shea asked what the Boards' thoughts were on presenting the Capital Improvement Budget as separate line items for the voters or should it be included in the total budget.

J. Bruno supports having them as separate line items. J. Leamy, R. Combs and R. Spaulding agreed that was the appropriate way to present the budget items.
