**ATTENTION CASTLETON TAXPAYERS!**

Enclosed you will find your 2023/24 property tax bill and a brief comparison of the 2022/23 year which ended June 30, 2023. See the enclosed worksheet. The municipal (town tax) rate shows a **reduction** in taxes from \$0.4895 to \$0.4796, however, the education tax rate increased as follows:  
Homestead - 2022/23 \$1.4065 to 2023/24 \$1.4623  
Non-Homestead - 2022/23 \$1.6190 to 2023/24 \$1.7351  
The education tax is why your overall property tax has increased. Property taxes are based on each \$100 of your assessed valuation.

We are pleased to introduce HeyGov as our newest platform. Some of you may have already begun using this to report an incident (non-emergency) or to purchase an annual transfer station permit, beach pass or pickleball pass. if you pay your property tax or sewer charges online through your bank account. Paper checks are mailed to us- it is not an electronic transfer. Interest and penalties will be applied if received outside of the grace period and the address is incorrect. **Or sign up for our quarterly direct debit program** that is an electronic transfer. Forms available on our website or soon on HeyGov.
