Response to Procedural Order Re Information Session, Public Hearing, and Site Visit and Motion to Revise Schedule

On March 7, 2022, the Commission directed Stone Mill Solar ("SMS") to work with the other parties in this proceeding to schedule a public information session, public hearing, and site visit. SMS has conferred with the other parties, all of whom are in agreement that all three events can be held on the same day, Wednesday, March 30, 2022, subject to the Commission's concurrence. SMS proposes the following schedule for that day:

- 4-5 PM—Site Visit
- 6-7 PM—Public Information Session
- 7-8 PM—Public Hearing

The Castleton Town Office meeting room, located at 263 VT-30, is reserved on the evening of March 30th for the public information session and public hearing. The facility is capable of conducting the meetings both live and remotely via the internet. SMS assumes that the Commission will want to establish the method for providing remote access, e.g., GoToMeeting or a similar service, but if not SMS is prepared to assist as needed.

The location of the site visit is 680 E Hubbardton Rd, Castleton, VT 05735. Visitors may park on the western side (the right side upon entering) of the RMG Stone Products building located at this address.

Because the site visit, public information session, and public hearing had not been scheduled at the time of the Commission's Scheduling Order issued on December 21, 2021, SMS proposes the following changes to the remainder of the Commission's procedural schedule:
